

I wish there were more tournaments to talk about, but unfortunately our state has chosen to take this thing to the next level. Many of the rural clubs have been able to re-open and even host a few small



I find it ironic that the bill is authored by a representative that lives in Tarzana. A southern California city named for Tarzan by one of its lifelong residents Edgar Burroughs the author of Tarzan. On a bit of better news, the 3030(Kalra) bill which would have placed needless additional restrictions

and protections on California wildlands and may have threatened hunting and fishing opportunities did not make it out of Senate appropriations. thanks to our Government Relations representative Bill Gaines for his tireless efforts on behalf of CBH/ SAA a n d other conservation groups to counter these terrible pieces of legislation being introduced by our elected representatives. Please continue to monitor the CBH/SAA website and

social media for up to minute information on legislation affecting you, the California archer.

Legislative Information By Robert Moore

The FGC meeting was held August 19-20, 2020 by webinar/teleconference. Wednesday meeting is Marine items and no watches there. Thursday agenda is related to inland fisheries and mammal regulations. Items of interest on the agenda #21 – Department Informational Items (B) Wildlife and Fisheries Division, and Ecosystem Conservation Division I. Bacterial Outbreak at Fish Hatcheries

The outbreak of Lactococcus garvieae has caused DFW to euthanize fish at three hatcheries and temporarily halt its fish stocking program in Southern California. DFW is expected to propose several new topics for referral to the Commission's Wildlife Resources Committee (WRC).

#23 – Simplification of Statewide Inland Fishing • Separate the regulations for inland trout (non-anadromous waters) from those for steelhead and salmon (anadromous waters) to help provide greater clarity for anglers • Replace the district regulations with statewide regulations separated for trout; and

• Standardize and consolidate the "special fishing" regulations. Regulations used to manage trout populations in California to be addressed under this proposal include: • Seasons (specified dates for opening and closing) • Bag and possession limits • Size limits • Gear and bait restrictions

The Commission is scheduled to further consider and adopt changes to statewide inland fishing regulations at their October 15th webinar/teleconference meeting.

At recent WRC and full Commission meetings several members of the public have voiced concerns regarding the increasing frequency of human/wildlife conflicts resulting from coyotes living in California's urban areas. In response, WRC recommended that the Commission host a discussion with DFW and the public on steps that can be taken to address the conflicts. Following discussion at this meeting, Commission staff will recommend that the Commission and DFW jointly host a public workshop to further explore topics such as: • Urban coyote research and additional needs • Agency authorities and jurisdictions • Options for developing coyote plans at the local

I. Petition #2020-008: Elk Hunting Suspension In early April 2020, DFW discovered the presence of a novel disease, treponeme-associated hoof disease, affecting the hooves of Roosevelt elk in Del Norte County. In response, animal-rights interests have quickly taken this opportunity to petition the Commission for an immediate "emergency" closure of elk hunting in the Northwestern Elk Hunt Zone. Under this item, the petition – submitted to the Commission in June by the Environmental Protection Information Center (EPIC) – will be considered. At this meeting, the Commission may deny, grant, or refer the

Legislative Information from page 5- petition to a Account and require the incremental revenue to be committee, staff or DFW for further evaluation or deposited in that Subaccount and available information-gathering.

Under typical Commission procedure, the first step would usually be for the Commission to refer a petition of this nature to DFW for review and recommendation. However, in this case 2020 elk tag quotas have already been approved by the Commission and already allocated, via draw, by DFW. As such, the Commission would have to take "emergency" action to immediately revise the already approved 2020 mammal regulations to close elk hunting for the upcoming season in the Northwestern Elk Hunt Zone. DFW leadership is not expected to support the petition's request for an emergency closure of elk hunting in 2020. Further, recent discussions with DFW leadership have indicated that the Department does not believe that there is any reason to close hunting at any time due to the elk hoof disease. Consistent with this position, at this meeting, Commission staff will recommend (and DFW will support) that an emergency situation does not exist and that further discussion of the implemented) wrongly over the next decade, the petition be referred to the Commission's Wildlife Resources Committee (WRC). The next Wildlife Resources Committee meeting will be September 17 by webinar/teleconference. No agenda has been posted at this time but reference the #22 commission discussion above.

Legislation

AB 1387 (Wood) – Sport Fishing Licenses: 12 Consecutive Month Licenses; would, in addition to offering California residents a traditional calendar year fishing license, require DFW to offer a license that is valid for 12 consecutive Existing law prohibits the sale or transfer of a firearm by a months beginning on the date of purchase upon payment of a fee that is equal to 130% of the cost of the traditional calendar-year sport fishing license. AB 1387 would require DFW to provide applicants for these licenses the option of rifle – to a person 18 years of age or older who possesses a signing up for automatic renewal of the license by electronic payment and would set the fee for licenses issued upon automatic renewal at the same price as a calendar-year sport (D/25-Glendale) did little more than require salespersons to fishing license. Update: Dead, hearings cancelled by author, visually inspect and record the number, validity dates and failed legislative deadlines

AB 2106 (Aguiar-Curry) –Nesting Bird Habitat Incentive Program: Upland Game Bird Stamp/State Duck Stamp. Legislation passed in 2018 required the Department of Fish & Wildlife (DFW) to establish the "Nesting Bird Habitat Incentive Program" and authorized DFW to make payments or provide other incentives to encourage landowners to voluntarily cultivate or retain upland cover crops or other upland vegetation on their idled lands to provide habitat and nesting cover for waterfowl, upland game birds, and other species. AB 2106 would help generate the funding necessary to implement the Nesting Bird Habitat Incentive Legislation has to be completed by August 31 and sent to Program by raising the California upland game bird stamp the Governors for veto or signature. and the state duck stamp by \$5 each. upon appropriation to DFW for the Nesting Bird Habitat Incentive Program. Update: Dead, failed to be pulled from suspense file

AB3030 (Ash Kalra) Protect Lands and Water: Would declare it to be goals of the state to, by the year 3030, protect at least 30% of California's lands and waters; to assist with the protection of 30% of the nation's oceans; and to support efforts to protect at least 30% of the world's lands, waters and oceans.

AB 3030 is dangerously poorly written and ambiguous. Among many other things, although the bill calls out goals for the total percentage of our lands and waters that should be "protected", its language fails to identify the extent of existing protections already in place (i.e. the baseline). Even more troubling, the bill does not expressly define what the legislation means by the word "protect". As such, should the intent of AB 3030 be interpreted (and thus "protections" the bill calls for in AB 3030 could easily result in sweeping closures to public access to much of California's lands and waters, and the hunting and fishing opportunities they currently, or could provide.

Update: Dead, failed to be pulled from suspense file

SB 1175 (Stern). Animals: prohibitions on importation and possession of wild animals: live animal markets. Update: SB 1175 was pulled off suspense, heard, took on some nonsubstantive amendments and passed out of the Assembly Appropriations Committee and to the Assembly Floor today. SB 1175 must be passed off the Assembly Floor, go back to the Senate for their concurrence of amendments taken on the Assembly side, and to the Governor's desk by close of Session August 31st to remain alive.

SB 914 (Portantino) – Firearms: Hunting Exemptions. licensed firearm dealer to a person under 21 years of age, but exempts from those provisions the sale or transfer of a firearm – other than a handgun or semiautomatic centerfire valid, unexpired hunting license.

As introduced, SB 914 by Senator Anthony J. Portantino GO ID of the hunting license of individuals under 21 years of age who desired to purchase a long gun. However, as amended May 11, 2020, SB 914 would now place numerous additional costly and needless restrictions on the purchase and transfer of firearms and firearm parts by law abiding citizens, while also threatening many youth hunting and shooting programs. Update: Pulled off suspense, heard and passed out of the Assembly Appropriations Committee and to the Assembly Floor today. SB 914 must be passed off the Assembly Floor and to the Governor's desk by close of Session August 31st to remain alive.

CALIFORNIA BOWMEN HUNTERS BIG GAME CLUB POSITION STATEMENT

The California Bowmen Hunters-Big Game Club (CBH-BGC) has historically utilized the Boone & Crockett (B&C) / Pope and Young (P&Y) Measuring system (copyrighted 1887) to record trophy animals taken with a bow and arrow in California. CBH-BGC received copyrighted, but revocable, permission many years ago to utilize not only their scoring system, but their score forms, affidavits, and use of the term 'Fair Chase'. Both P&Y and B&C require an almost identical code of conduct and ethical requirement listed under their respective Fair Chase Affidavits for any animal submitted to their record programs.

On June 14, 2020, your CBH-BGC voted unanimously to continue to align with Pope and Young and Boone and Crockett's Fair Chase requirements and measuring system. Under their rules of "Fair Chase" neither club allows any animal harvested using electronic rangefinding bow sights (Garmin, Burris, IQ, etc.) for entry into their records program. This would violate number III of B&C's Fair Chase Affidavit, as well as #7 of P&Y's Fair Chase Affidavit. (http://www.boone-crockett.org/bc-position-statement-fair-chase - http://www.pope-young.org/fairchase/default.asp)

While the use of such electronic sights may be legal in California, they, unfortunately, will not be accepted into the CBH-BGC records program, as they clearly violate our rules of Fair Chase. This should, in no way, minimize the trophy taken or the hunter who utilizes such equipment; we (CBH-BGC) simply must maintain the integrity of our records program and continue to practice and encourage Fair Chase.

The Rules of Fair Chase for P&Y and CBH-BGC:

The term "Fair Chase" shall not include the taking of animals under the following conditions: ()

- 1. Helpless in a trap, deep snow or water, or on ice.
- 2. From any power vehicle or power boat.
- 3. By "jacklighting" or shining at night.
- 4. By the use of any tranquilizers or poisons.
- 5. While inside escape-proof fenced enclosures.
- 6. By the use of any power vehicle or power boats for herding or driving animals, including use of aircraft to land alongside or to communicate with or direct a hunter on the ground.
- 7. By the use of electronic devices for attracting, locating or pursuing game or guiding the hunter to such game, or by the use of a bow or arrow to which any electronic device is attached with the exception of lighted nocks and recording devices that cast no light towards the target and do not aid in rangefinding, sighting or shooting the bow.
- 8. Any other condition considered by the Big Game Committee as unacceptable.

In closing, the Fair Chase concept extends beyond the hunt itself; it is an attitude and a way of life based in a deep-seated respect for wildlife, the environment, and for other individuals who share the bounty of this vast continent's natural resource.

JUST A FEW THINGS

NEW RECURVE CATEGORY HAS BEEN ADDED (RECURVE OFF THE SHELF) In the past, off the shelf recurve and traditional recurve (elevated rest, plunger and a 12inch stabilizer) shooters shot in the advantage to traditional. separated, and off the shelf recurve has its own category, with maximum distance of 50 yards. Traditional recurve yardages stay the same. We are hoping that this will encourage more off the shelf archers to shoot state tournaments. The more support you give the more we can get done.

2020 STATE TRAD. SHOOT There were 161 shooters; 20 more than the previous year. Traditional archery is growing. Everyone had a great time and I enjoyed putting it on. I would like to thank David Roach, President of Verdugo Archer, for letting CBH use their facilities for the shoot. I also would like to thank Bill England for the tremendous amount of work he put in to make the shoot the success it was.

2021 STATE TRAD SHOOT We are very fortunate to have the Fresno Archers host this coming years Trad. Shoot. This is a great venue that includes a huge clubhouse, great fireplace, and plenty of room for dry camping, RV and trailers to park. More on the 2021 shoot and venue as we get closer to the shoot. This year you are going to be able to sign up for the shoot online.

MASTER CALENDAR Club tournament directors: When you are setting up your tournament schedule for the year, look at the CBH/SAA Master Calendar. When there are too many shoots on the same day, it results in all of them having mediocre attendance. DIY - European Mounts

By Tim Crabtree

When an antlered animal is taken in the velvet, the head should be immediately removed and placed in a freezer if possible. In this manner the flesh doesn't rot and cause the velvet to fall off. One way to preserve velvet is to coat the velvet antlers in acetone. This process will dry out the velvet and harden it and more thoroughly attach it to the underlying bone.

For animals without antlers the first step is the same, the head should be removed and placed in a freezer as soon as possible. If this is not possible, the hide and as much meat as possible should be removed ASAP. The longer the skull sits in ambient temperature with hide and meat on it, the more the fat will stain the bone.

On ungulates, done in the European style, the lower jaw rarely left attached. Most taxidermists in fact will charge extra to clean the lower jaw. Consequently, the lower jaw is generally removed. All the above procedures should be done before the skull is taken to the taxidermist if this is your choice. This will not only save the hunter money but will result in a higher quality and more professional looking mount. The most important thing in properly caring for a skull, at least a European mount, is to get it cooled down or frozen as soon as possible.

ELK & SWEET POTATOES JBARR

If you like sweet potatoes, you'll LOVE these roasted sweet potatoes with sage butter. They are very easy to make and a perfect side dish to accompany elk, venison or antelope steaks. Be sure to drizzle a little sage butter on top of your sliced steak when serving together!



Ingredients

3 or 4 - 4'' inch elk backstrap steaks (venison can be substituted)

1 tablespoon garlic powder

1 teaspoon kosher salt

Cracked black pepper (as much as you want)

3-4 Sweet Potatoes

6 tablespoons butter

1/4 cup fresh sage leaves (chopped)

Fresh chives

Sour cream (optional)

Sage Butter:Melt 5 tablespoons of butter in a small skillet over low-medium heat. Add chopped fresh sage and cook until leaves become slightly crispy. Be careful not to burn butter. Remove from heat.

Roasted Sweet Potatoes Heat oven to 425 degrees. Take a whole sweet potato and pierce it with a fork a few times. Microwave for 6-7 minutes (depending on how big your sweet potato is). Once the potato has been cooked in the microwave cut the potato in half. Then, without cutting all the way through on the ends you cut each half into squares. Spoon some of the sage butter over the potatoes. (Reserve some for your elk.) Season with salt and pepper. Bake the sweet potatoes for 15-20 minutes in the oven.

Seared Elk: Mix all garlic powder, kosher salt and black pepper together and rub on all sides of elk steaks. Be sure that your elk steaks are room temperature before cooking. Melt remaining butter in a cast iron skillet over high heat. Add elk to the HOT skillet and brown on all sides until you get a rich dark coloring. Remove from skillet and let rest covered loosely with foil for 10 minutes. Slice against the grain when serving and top with remaining sage butter! ~Enjoy!





Perseverating, or rehashing things many times is often associated with negative events or bad results or memories. These of course can create a negative attitude and life experiences.


Retrospect can lead a person to the discovery of many things that in the moment went un-noticed.


POPE AND YOUNG HEADQUARTERS - ART & RODNEY -
