

A Message from the President

Legislative Team Update

Hello CBH/SAA friends and family!

Following up on last month's **AB 2571 Firearms: Advertising to minors** update, "clean-up" legislation has been introduced to the Legislature in the form of Public Safety Budget Trailer bills SB 141 and AB 160, pending in both the Senate and Assembly. These two massive bills deal with a variety of issues, but both lead off with the California Hunting and Conservation Coalition (CHCC) cleanup language of AB 2571 (refer to AB 160, page 7, lines 10 through 17; and SB 141, page 7, lines 4 through 11). Both bills contain an "urgency clause", which will make our language go into effect immediately upon the bills being signed! August 31, 2022, is the last day of the legislative session, so stay tuned to CBH/SAA social media and websites for updates.

Unfortunately, the California Rifle and Pistol Association (CRPA) lawsuit and request for an injunction against the enforcement of this new law did not see anticipated relief. According to updates on the CRPA website, prior to the hearing on the preliminary injunction, "the State filed a request to have the court postpone that hearing because the legislature "may" pass some draft language that they think will make AB 2571 work." Despite CRPA's counter request, the court sided with the State. CRPA and other plaintiffs in the case filed a Writ of Mandamus to force the court to rule on the injunction no later than August 29. On a positive note, online registration is open for the **CBH/SAA Showcase Tournament and Legislative Defense Fundraiser** on October 23 at Oranco Bowmen in Chino, CA. We look forward to seeing you in October and hope that you will take advantage of this opportunity to connect with others in the archery community, interact with vendors, and participate in our raffles! Another successful State Target Tournament

Regardless of whether this was your very first tournament or your 100th, a good time was had by all. Depending on where the tournament was held, archers dealt with wind, sun, or fog. The terrain also varied from host site to host site. Some archery ranges were level and tree-lined; others, you shot from an elevated platform. At some host sites, your shooting line changed with each distance, at others, the target butts were moved closer so that you stayed in shade all day. No matter where you participated, you got to shoot your bow!!

Results are coming in and will be published in the November Newsletter, or December's at the latest depending on when I receive the scorecards from host sites. This month, the results and new state records should be on the CBH/SAA website.

Online registration was a requirement this year. For the most part, it worked well. There were a few snafus but I was able to work with RunReg to fix them. I certainly learned a lot about how to set up an online portal; what to do and what not to do. We had close to 400 archers competing in this year's tournament. Most archers were able to register easily. For those that had difficulty, I was able to assist them. Other benefits of the online registration process include:

- Host site got a list of archers who registered for their event, which was updated weekly.
- Target Assignments were done before the day of the shoot, allowing archers to shoot with their competition.
- Archers were able to read the Waiver during the registration process, instead of reading it on the day of their event.
- NFAA, CBH, and USA archery membership verification was done before the event.
- Many JOAD archers, who are part of USA archery were not aware of needing a CBH/SAA membership in order to compete for awards. They were able to obtain a CBH/SAA membership quickly.
- Pre-Printed scorecards were sent to each host site, with the archer's name clearly printed on each card.
- Results will be published 1-2 months earlier than usual...November or December instead of January.
- Host sites will receive their payment from CBH/SAA earlier. They will receive \$10 for every archer who competed.

This year, the scorecards were revamped by Lisa Rodriguez, an archer with Pasadena Roving Archers. She was able to fit 2 scorecards on one 8X11 sheet, thus cutting the printing costs in half! Thank you, Lisa!

As many of you know, this is my last year running this tournament. It has been a pleasure and an honor serving CBH/SAA and you, my fellow archers. I have enjoyed visiting many of the host sites, meeting you at your local archery clubs, and hearing your stories of how you got into archery. So many of you are truly the nicest and kindest people I have ever met. You have blessed me with your friendship. I look forward to seeing you out on the range. May you continue to enjoy this wonderful sport of Archery.

Pictured on the cover is Gilbert Olivas and his first beaver in 1976. Many of you know our long-time friend and you are lucky if you do. The archery world would not be the same without him. What an honor it is to have a piece of archery history created by Gilbert Olivas!

A Beaver Tale from page 6 - Some of the critters that are available during the furbearer season are beaver, mink, raccoon, opossum and muskrat. I remember Gilbert telling me a story about the first beaver he shot. He was hunting in central-southern California not too far off a major HWY. Gilbert and his hunting buddies would sometimes drive their car to the very edge of the banks of a body of water or canal and put his fiberglass boat, with a 7.5 Evinrude motor, into the water. Other times they canoed up and down the canals hunting for critters with a hand held, 6 volt flashlight. Gilbert shared how excited he was when he shot his first beaver. The event took place in the Sacramento River Delta in 1976.

Gilbert told me that the best time to get on the water to hunt beaver is just before the tide drops. Yes, the Delta water is freshwater but the ocean tides do affect the water level. Being out there at that time will better your chances of seeing and getting a beaver. One of the biggest beavers Gilbert ever saw was a 72-pounder that was shot by a young lady named Crystal.



Thank you Mr. Gilbert Olivas for sharing your stories of good times and rich hunting history with me and others and for paving the way for the love of bow hunting!



How Pope and Young Got Started

Gilbert and his hunting partners, Joe Wiley and Charley Pacheco didn't stop with beavers. They continued hunting the Delta waters for mink, raccoons, and any other small game species that lived there. They say the Delta comes alive after dark and what fun they've had chasing those critters. These three hunters have a lifetime of stories and enjoy talking about their escapades over beaver stew or BBQ'ed beaver. They love sharing their memories.

In 1958 the Pope and Young Big Game Trophy Competition was created by the National Field Archery Association (NFAA) with Vice President Glenn St. Charles as the chairman. It remained an NFAA program until 1963 when it became a separate entity.

An NFAA election was held, and Karl Palmatier was re-elected president. Continued. pg 9



Times Gone By

Golf is a sport enjoyed by many an individual, both young and old. According to <https://riversedgegolfbend.com/bend-oregon-golf-blog/demographics-of-golf/> nearly 25 million golfed in the United States during 2020 (even with the onset of COVID 19).

Conversely, 21.6 million Americans (2014) shot archery as stated by archery [trade.org](https://www.trade.org). Of the United States 235 million citizens 18 and older, 9.2 percent participate in archery at some level. More specifically, 4.1% of adult Americans shot only target archery; 2.2% exclusively were Bowhunter and 2.9% participated in both. <https://insidearchery.com/ata-survey-21-6-million-americans-shoot-archery/> Further stated Hunters purchased over 15.6 million hunting licenses in 2018. [imarcgroup.com](https://www.imarcgroup.com/global-archery-equipment-market) (<https://www.imarcgroup.com/global-archery-equipment-market>) reported the global archery equipment market reached \$3.45 Billion USD (that's a lot of zeros!) in 2021 alone.

The same group projects this market to soar to US \$5.2 Billion by 2027. All this to raise a question,... is either archery, or bowhunting dying? Currently not! Have they regressed from what they once were? Again, a resounding NO! Will there be a future for either? Absolutely! And all this growth has taken place amidst continual legislative attacks on hunting seasons and the purchase of "sporting goods" and any related items they can inflict excise taxes upon.

Looking back to the late 1950's and early 1960's California bowmen and target archers were

working on a united front. A select few went to Game Commission hearings and voiced their opinions face to face with four women set to STOP bowhunting for big game in our state! These women claimed an arrow was not an effective tool to harvest big game. They speculated a broadhead was not a lethal method to dispatch large animals.

Way back then our "legal team" led by Dr. Smalley presented testimony and evidence to the contrary and archery deer seasons were voted into law.

Times are actually not all that different now - times GONE by are actually still happening. Read Amanda's Legislative report concerning the continual assaults on hunting. Follow the introductions of new sanctions to limit or erase seasons without scientific background. Get involved, offer your help, write your legislators or/ congressmen to voice your concerns. Donate money to our Legislative Team to rally for enjoyed freedoms - lest they be stripped away.



More on times GONE by,... about thirty plus years in fact! An acknowledgment is certainly proper and well deserved. For those years Sandy and Gary McCain have supported and led the way; both in the field and on the archery ranges they dominated. The years are more numerous than can be counted; they have served on our Big Game Committees. But even far more numerous are the times they have each encouraged one of us, offered their time, energy and much of their money. Remembering Tony DiMiceli Craig Fritz

They say that we lose more and more of our friends as we grow older, but that doesn't make it any easier to say goodbye to someone that we have grown to respect and love. And so it was when I learned of the passing of Tony DiMiceli on August 13, 2022. Tony was one of my biggest supporters and best friends during my years as 2nd VP for California Bowmen Hunters. He didn't know it, but he was a big reason that I was successful. Tony was one of those men that you would want to play on your team. He was always right there to help, to do anything to create success.

Years ago, Tony was always a leader when the Big Game Club launched a measurer's contest that earned our certified measurer's points for awards for each animal that they measured. He was a founding member of the Long Beach Bowhunters that brought many, many new people not only into archery and bowhunting but also to join as members of CBH. Not only did Tony recruit these new bowhunters but he also made sure that they were successful and would grow to love our sport by mentoring and guiding them to make friends with other club members.

Tony was a charter member of the California Bowmen Hunters when it was formed back in 1962. I believe there is only one other person that is a living charter member, so Tony's loss is huge to all of us. He believed in our organization and was constantly pushing to recruit others to join in the fun.

Tony was awarded the Big Game Club Lifetime Achievement Award for his lifelong service and commitment to archery. He was a Senior Member of the Big Game Club. I remember years ago that Tony told me that he had saved every single CBH newsletter that he had received! He was a good man and a very fun person to be around. While he had slowed down in the past few years, Tony has been bowhunting for something like 70 plus years!

Tony also raised one of the great California bowhunters in his son, Vince. Based on his long list of entries and awards, Vince is arguably one of the finest turkey and Pacific Hybrid bowhunters in this state. I'm sure that Vince was still learning secrets about being a successful bowhunter from his father all the way to the end.

Personally, Tony was my friend. He never missed an opportunity to thank me for what I did during my years with CBH. Cont. on page 11



From Our Historian from page 7 Glenn was elected Vice President for a second time. He was asked to continue as head of the Hunting Activities Committee; however, at this point, St. Charles decided that the workload needed to be separated. Much remained to be done in certain NFAA bowhunting programs that would be of concern only to the primary Hunting Activities Committee. At the same time the Seattle-based group, under Glenn's leadership, needed to concern itself with record keeping. The decision was made to form two distinct groups.

"The next two years were hectic." Glenn recalls, "measures had to be trained and appointed in appropriate areas throughout the country." Up to this time, we had been using every helpful Boone and Crockett measure. The entries continue to pour in. Bowhunters everywhere seemed delighted to have something to relate to at last.

Early in 1960 preparations were made for another awards banquet in Grayling, Michigan, the site of the NFAA tournament. Continued on page 10

Historian from page 9 Tentative proposals were advanced so that the bowhunters who gathered there could discuss the possibility of a separate organization.

By the time of the tournament in late June, the thirty-five very interested bowhunters who attended the gathering were in agreement. There was a need for a club similar to the Boone and Crockett Club which would record North American big game animals harvested with a bow. The club was dedicated to good conservation practices, quality hunting, and fair chase. It was determined that the club would be named after Dr. Saxon Pope and Arthur Young as a lasting tribute to these bowhunting pioneers. Recognizing the need for a good base, the group immediately sought to obtain the 1957-1960 records, which had been completed by the NFAA Hunting Activities Committee. St. Charles, attended the NFAA Executive Committee meeting as Vice President expressed the aims and desires of the Pope and Young group. After some debate, the NFAA reluctantly but graciously agreed to release these important records. Six months and a considerable amount of correspondence later, the Pope and Young Club actually came into being on January 27, 1961. The first formal meeting of the club was held in Seattle, Washington, which was to be the organization's headquarters for many years to come.

And now to this day, I am a proud member of the Pope and Young Club that Glen St. Charles started so many years ago. Doug was one of the club's first elected Board of Directors members and was later elected Big Game Chairman of Pope and Young. Legislative Team Update from page 5- Finally, I'd like to share with you the new California R3 Community Calendar on the CDFW Hunting and Fishing: Recruit. Retain. Reactivate (R3) website (<https://wildlife.ca.gov/r3>). I encourage our archery clubs to take advantage of this free opportunity to promote your events and for our members to check out opportunities to participate in other non-profit events promoting outdoor recreation, including hunting and fishing.

Other Legislative Team actions and updates this month:

SB 945 Falconry/Peregrine Falcons passed off the Assembly Floor and is now on the Governor's desk for his consideration of signature. CBH/SAA signed a conservation coalition letter to the Governor requesting his signature on SB 945.

SB 918 Firearms/CCWs, legislation that went far beyond dealing with strictly CCWs and would have also impacted the public transport of all firearms – including sporting arms used for hunting and target shooting – by: 1) Effectively banning the possession of unloaded and cased shotguns, rifles and handguns in all areas of airports not controlled via screening of persons and property (“non-sterile”) including parking areas, baggage claim, ticket counters and much more; and 2) Effectively banning the possession of unloaded and cased shotguns, rifles and handguns in “non-sterile” areas of public transportation facilities, such as trains, buses and cabs. To address our concerns, CHCC lobbyists reached out to the author's office and the Department of Justice regarding our concerns and launched an opposition campaign for the pending Assembly Floor vote. In direct response, SB 918 was amended to add language which expressly ensures that public transit of sporting arms used for hunting and shooting would not be impacted, should the bill pass and be signed into law.

• In response to strong opposition from the CHCC and those CBH/SAA members that responded to our **CALL TO ACTION** email and contacted their Senator, **AB 1227 Firearms and Ammo Excise Tax** was amendment to exempt long guns/long gun ammo purchased licensed hunters. CHCC lobbyists continued to actively work the Senate to ensure that our representatives are aware that we remain adamantly opposed to AB 1227 – regardless of the carve out they gave hunters. As previously noted, August 31, 2022 is the last day of the legislative session, so stay tuned to CBH/SAA social media and websites for updates.

• **SB 505 -- Civil Law: Firearms Liability and Insurance** died in Assembly Appropriations Committee. CBH/SAA opposed this legislation.

• **AB 865: Junior Hunting License Age Eligibility** was held in Senate Appropriations Committee and is also dead. The CHCC and our lobbyists did all possible to secure passage of SB 865 out of Committee, including meeting with the Senate Appropriations Committee staff to discuss the bill. CBH/SAA was a strong supporter of this legislation. Continued on page 11

- CBH/SAA signed a coalition letter to the Federal Railroad Administration (FRA) requesting that they require the proposed Brightline West "SoCal to Vegas" High-Speed Rail project to include at least three wildlife overpasses as mitigation to avoid the project's concrete barrier walls from permanently blocking critical California wildlife corridors.


